## By-laws Change Paves the Way For Our First Paid Employee

At the September membership meeting held at the Harvard Sportsman's Club, a proposed by laws change outlining the proposed stipend for the Association Secretary was ratified unanimously by the membership.

Last spring, long time member Mike MacDonald (Westminster P.D.) made a motion that the Association Secretary be compensated for the long hours he devotes to MLEFIAA. The by laws already provided for the Secretary to receive compensation but was silent on how it

was to be handled.

After lengthy discussion, the Executive Board put together a by law amendment that was in line with the membership's wishes and provided fiscal responsibility by setting parameters for this change. The section on Salaries in Article IV was deleted in its entirety. It was replaced by wording which provides for a monthly stipend of \$150 effective October 1, 2006. This stipend will be paid provided the Association maintains a total cash asset of \$2500 or more. If our assets fall below that amount, the stipend is suspended immediately. The Executive Board may vote to reinstate the stipend if the total cash assets rise to \$3000 or more. No retroactive payments are allowed. The E-Board may vote to discontinue the stipend at any time.

The Board felt this maintained the intent of the motion while providing necessary security for the Association's assets. Because of the income generated by the Manual CD sales, we are financially comfortable at this time.

## New Storage Facility Delivered to MLEFIAA

On October 9th, MLEFIAA took delivery of a new 40 foot storage container at the Harvard Sportsman's Club. Two years ago we began renting a 20 foot unit from Eagle Leasing. With the acquisition of more than a dozen steel targets and other equipment, this was deemed the best way to keep all our equipment safe, dry and in one location.

In this short time, we filled the 20 foot unit and it became clear

we needed a larger one. The only real decision was to rent or purchase. After looking at all the factors including the ongoing rental fee, the Board decided to purchase a used forty foot marine shipping container. This was based on the inherent strength of the marine unit and low profile compared to a conventional over the road trailer. The unit was cleaned and the doors were overhauled. A new coat of paint was applied to the exterior. Most importantly, we

installed a wide double steel door in the middle of the unit. This will allow better access to gear stowed in the back.

We are looking for metal shelving to organize storage and will build a ramp to both doors.

The Association would like to thank member Greg Newman for his assistance in obtaining permission to place the unit on HSC property and for the site work in preparation for the unit.

Following the congressional proclamations, Jim received an official acknowledgement from Governor Mitt Romney for his service. Jim's service with the old Training Council, the MPTC and as a Board member of HSC has been priceless to our Association.

While Jim may have been able to retire from both the Concord P.D. and the MPTC, he remains active as an appointed Training Coordinator for MLEFIAA. His duties are directed towards maintaining the quality of our training and acting as a liaison with the Harvard Sportsman's

Club where MLEFIAA conducts about 90% of its training operations. Jim also serves as our Director of Range Operations during the Conference and other trainings conducted at the range.

On behalf of all MLEFIAA members, we wish Jim well and look forward to seeing more of him now that he is feeling better and doesn't have the Commonwealth distracting him from his MLEFIAA duties.



# Product Review - Safariland Model 6070 "Raptor"

I purchased a Safariland Raptor Level III holster for a Glock Model 23 about a year ago when looking for an alternative to the department mandated SSIII. While there is nothing wrong with the older SSIII design, experience has found that many officers will not use the second (trigger guard) snap. Either because the user is lazy or because the tolerances are so close on the strap length, it is extremely difficult to engage

the snap (and the user is to lazy to make it work), I see to many unsnapped holsters.

The new Raptor is a perfect replacement for any department using the SSIII. The draw sequence is close enough so that transition training is minimal. It is available in several finishes which will match most every existing duty gear including Nylon.

The key benefit is in reholstering. Merely inserting your duty

pistol back into the holster returns you to Level II. A quick flip of the hood brings you to Level III. This is a huge improvement over the older design in both speed and ease of reengaging the security features. Want more security? Add the Sentry device to go to Level IV.

The Universal Belt Loop was a little uncomfortable at first but I am getting accustomed to it.

Two thumbs up for this holster.
