STANDARDS FOR MEMBERSHIP

ACTIVE MEMBERSHIP

Active membership is open to:

All duly sworn full time, part time, and volunteer law enforcement officers of any duly constituted local, county, state, federal or specialized law enforcement agency within the United States of America; whose official duties include the training of other law enforcement personnel in the proper law enforcement use of firearms; or whose duties involve the maintenance and repair of law enforcement firearms for their respective agencies.

Upon retirement, active members may choose "Life" membership (no dues and no ability to vote or hold office) or "Retired" membership (continue to pay dues and are allowed to hold office provided they continue to remain active in firearms training).

ASSOCIATE MEMBERSHIP

Associate membership is open to:

- a.) Non-sworn personnel working within a law enforcement or criminal justice agency within the United States and sworn law enforcement outside the United States whose duties include firearms training and education.
- b.) Representatives of private industry who are engaged in the design, development, manufacture, or training in firearms, ammunition and other related technologies designed for law enforcement use.

ANNUAL DUES

- Annual dues are \$30.00 (U.S. funds) per year and are payable at the time of application.

- Renewals are due and payable on or before June 30th of each year.
